

Trent Vineyard Policy Statement on Safeguarding

PROTECTION OF CHILDREN AND ADULTS WITH/WITHOUT CARE AND SUPPORT NEEDS

The following statement was agreed by the Senior Leadership Team and the Trustees and reviewed on 18th September 2023 Trent Vineyard in all its ministries is committed to providing a safe and trusted environment for everyone who comes into contact with the church, including children and adults with care and support needs, and ensuring their well-being.

- We prioritize safeguarding, recognizing that we all have a responsibility to help prevent the physical, sexual, psychological, financial and discriminatory abuse and neglect of children and adults and to report any such abuse that we discover or suspect.
- We recognise the personal dignity and rights of both children and adults with care and support needs and will ensure that all our policies and procedures reflect this.
- We believe all adults with care and support needs and children should enjoy appropriate access to the life and ministries of Trent Vineyard where safe to do so.
- We undertake to exercise proper care in the selection and appointment of those who will work with children and adults with care and support needs.
- We believe everyone should be valued and feel safe. We want to make sure that all children and adults with care and support needs involved in the life of Trent Vineyard know this and are empowered to tell us if they are suffering harm.

We are committed to:

- Following statutory guidelines in relation to safeguarding children and adults with care and support needs and Trent Vineyard will ensure that as a place of worship/organisation all workers (paid and unpaid) will work within the agreed procedure of our safeguarding policy.
- Implementing the requirements of the Equality Act 2010 and all other relevant legislation.
- Supporting, resourcing and training those who undertake this work.
- Ensuring that we are keeping up to date with national and local developments relating to safeguarding by working in partnership with Thirty one: eight and other organisations.
- Encouraging everyone to embrace and abide by the safeguarding policy and procedures.
- Supporting all those involved in the life of Trent Vineyard affected by abuse.

We recognise that:

• Children's Social Care Services has the lead responsibility for investigating all allegations or suspicions of abuse where there are concerns about a child. Adult Social Care
